Education sessions are presented on multiple tracks to address topics of interest at all levels, from object-oriented programming to sophisticated web development and scientific computation.**4b** (Code:) (Expenses \$ 45,151 including grants of \$ 45,151) (Revenue \$ 0)Sponsored Python conferences world-wide. Provided grants to assist with the funding of local Python conferences worldwide. The following major conferences were partially sponsored: PyData, Software Carpentry, PyCamp, SciPy, Kiwi PyCon, PyCon Canada, PyOhio, PyData Boston, PyCon Ireland, PyCon Brazil, PyCon Argentina, PyCon DE, PyCon UK, PyCon Spain, RuPy, PyCon ZA, PyCon Tennessee. The Foundation also sponsored a number of small Python programming "sprints".
